

"The students usually have the freedom to wear whatever type of dress or tuxedo they want, but this year it's going to change," Parker said.

With the alarming number of outfit requirements students are questioning whether or not prom is worth going to this

"Although it is my senior prom, I would rather not go than have to follow an unreasonable dress code," Hannah Gray (12) said.

The dress code is as follows:

-No mermaid style dresses. A mermaid dress fits tightly around the chest, stomach, and hips, then flares out at the bottom. Mermaid dresses have been banned at various other high schools across the area for being "too revealing" and "not school appropriate".

-Open back dresses are highly inappropriate and not allowed to be worn inside.

-All dresses are required to have sleeves. Due to the lack of coverage, girls must have some type of sleeve to hide their shoulders and arms. All sleeves must cover at least

New building in works for freshmen only

Due to increasing population, earlier this month Loveland City Schools released news that starting June 5th they will begin construction on a new building which will be called "The Tiger's Den." The new building will be put right behind the current high school and will be strictly for freshmen.

The construction will be completed by The Turner Corporation which has been ranked one of the top ten construction companies in the U.S. It is hoped that all construction will be complete by the end of the summer and the building will be ready for the 2017-2018 school year. This will change the setup of the current high school as it will only hold tenth through twelfth grade students.

Russia scandals put strain on Trump-Putin brotherhood

The investigations and scandals surrounding links of the Trump administration with Russia have reportedly proved taxing on the relationship between Donald Trump and Vladimir Putin. Sources say there have been greater obstacles to them bonding more closely since Trump was elected president.

"It isn't easy," Putin commented during a stay at Trump's Mar-a-Lago resort in Florida, "trying to keep up a relationship with my brother as world leaders. Helping little Trump become president of America was supposed to make contact more convenient, not the opposite."





The school district won the Clean Kitchen Award for having outstanding health knowledge and impeccable sanitation in the operations of kitchen facilities district-wide.

At the beginning of April, the Hamilton County Board of Health presented the award to the school for the seventh year in a row.

According to the Hamilton County Public Health Department the following criteria must be met to receive the award.

The facility must have fewer than three violations in the previous two years prior to making application. All of the facilities must have no critical

or repeat violations in the previous two years prior to making application.

The facility must meet one of the following food education criteria:

Two staff members at the facility must have a valid Level 1 Food Handler Certificate within the previous two year period; or

At least one staff member must have a current ServSafe or Level 2 Certificate.

The facility must have two years of inspection data available.

Loveland city plans on big developments in near future

There will be \$7 million invested into 170 new residential developments around Loveland, including new housing developments in The Heights neighborhood.

Other developments have been occurring outside of the Downtown area, with the recent completion of the new Starbucks.

"Outside of Downtown, the new Starbucks was recently completed, and very important McCluskey Development in our Commerce Park is scheduled to be completed by the end of May. The McCluskey project will bring 80 new jobs and new income to the city through our earnings tax," Mr. Kennedy said.

The Heights neighborhood will be seeing new affordable housing units go up, as the city is working with developers on the project.

The city manager David Kennedy provided details on the new developments happening in Loveland.

"The city is partnering with PIRHL Developers to complete an affordable housing project in the Heights. The project will include thirty six new affordable housing units and will include public park improvements to be utilized by a city residents. The [city of] Loveland enjoys diverse housing opportunities for our residents which adds to the quality and diversity of the city," Mr. Kennedy said.

Another housing project that will begin this year is the Deer Ridge II apartments on Loveland-Madeira Road.

"The Deer Ridge project has been long in the works and shows that development is happening in all corners of the city. The Deer Ridge development will supply high quality housing to new residents that will enjoy easy access in our downtown district along with being in close proximity to I-275," Mr. Kennedy said.

Some of the new housing developments include eight new townhomes which are being called The Brownstones, and are going to be available in the high \$300,000 range.

Statistics from Cincinnati Magazine said that the recent investment in new developments has increased the average price of a home in Loveland from \$273,000 in 2015 to \$310,000 in 2016

"I have only been with the city a little over two and half years so I cannot say [if Loveland has ever received this much development], but this is a significant amount of high quality development occurring throughout the city within a short time frame. Mayor, city council, and the city staff are working hard to manage the development and planning for the future," Mr. Kennedy said.

Right to be forgotten" law allows online censorship

ast month in the state of New York, there was a bill introduced, but later withdrawn, in the state assembly which proposed to allow individuals to require the removal of certain information online. Characterized as a "right to be forgotten," this information in question would be discarded from search engine results and cease to appear in searches for specific people or information.

This right to be forgotten, though recent in terms of digitalization, did not originate with this bill in New York, but came about and is already in implementation in the European Union. The nature of this idea, which is now law in the EU, is for people to be able to reasonably request for potentially private or slandering information to be taken off of web searches, or "delinked" from search engine results.


Now, the basis of this law is reasonable, but a problem arises when such a "right" is arguably misused. I don't mean to imply a Brutus-Caesar scenario, but this law provides for the possibility of censorship or infringement of free speech in that people in the EU are given the opportunity to remove some information rightfully accessible by the public that may not be decisively damaging to them or others.

The vagueness of this law is the main point of contention. The exact text of the law proposed in New York dictated the following: information could be removed, according to the *The Washington Post*, that is deemed to be "inaccurate, irrelevant, inadequate or excessive" and, perhaps quite significantly, "is no longer material to current public debate or discourse" with respect toward the individual.

The war on truth: ethical journalism proves under recognized, key to successful democracy

Many Americans have a tendency to overlook issue that may be the most important to them in favor of trivial, sensational issues. Unfortunately, the ever-important issue of ethical journalism remains vastly under recognized as the driving force behind a democratic

A free press that operates with integrity is the lifeblood of any society that strives for freedom. However, many news agencies are turning their backs on the traditional and ethical methods of journalism in favor of easy,

According to the Society of Professional Journalists, the news media has four principles to follow. These principles are: to seek truth and report it, to minimize harm, to act independently, and to be accountable and

Two of the worst perpetrators on both sides of the spectrum are Breitbart.com and Huffington Post.

Breitbart.com is a news site with a right wing bias



became renowned peddling for number falsehoods during the election season. Former chairman Steve Bannon

declared the news outlet "a platform for the alt-right."

These falsehoods reached a point where the country of Germany began an investigation of the website after they began publishing outright lies about the country, claiming that a "1,000-man mob" chanting "Allahu Akbar" set fire to a church on New Year's Eve." The Dortmund police department said that no such incident occurred, according to The Verge.

On the other side of the spectrum of biased news is Huffington Post. An example of The Huffington Post's blatant disregard for any ethics in journalism was shown during the 2016 election when the website frequently included an editor's addendum in their articles saying "Donald Trump regularly incites political violence and is

a serial liar, rampant xenophobe, racist, misogynist and birther who has repeatedly pledged to ban all Muslims—1.6 billion members of an entire religion—from



This gross and wholly unprofessional attack on political Trayvon Martin case, when news outlet MSNBC brazenly candidates by Huffington Post is relatively typical of the organization. They consistently publish thinly veiled opinion pieces as news.

The issue of ethics in journalism isn't limited exclusively to Huffington Post or Breitbart either. PEW Research Center conducted a regular survey in 2012 which asked Americans how they view 12 of the major news outlets. The survey concluded that only 56% of people view the news outlets as "believable," or in other words, trustworthy. This is a sharp decline from 2002, where 71% viewed the news publications as believable.

standards of journalism is evident in the culture of "breaking stories." The desire of the news-media to be the first to break a story leads to outright dangerous situations.

The danger of incorrect information being "broken"



becomes evident in situations that involve shootings. For example, in the January 2017 attack on a Quebecois mosque that left six dead, Fox news shooter was of Moroccan journalism.

Fox corrected their information with a follow-up tweet, but the initial tweet with erroneous information remained on the Fox twitter page for days. Fox news eventually deleted the tweet after several days, but by then the false information had circulated the internet and had been picked up by news agencies such as Breitbart.com and peddled as

The unethical journalism even goes so far to promote outright lies to the public. A well-known example comes

from the infamous the George Zimmerman/



doctored a phone call between Zimmerman and a 9-1-1 dispatcher in order to make him appear racist. George Zimmerman filed a lawsuit against MSNBC. The judge eventually dismissed the case despite Zimmerman received multiple death threats as a result of doctored audio clips.

A fundamental problem with the internet is that when a fake news story begins to snowball, it becomes impossible to correct the damage. Because when fake stories begin to circulate through news agencies, people begin to accept it

Hasty journalism leads to very real and tangible The seeming unwillingness to uphold the correct consequences, and could easily be rectified if journalists bothered to verify their sources.

As much as it is the journalist's responsibility to uphold a personal code of ethical journalism, it is equally the American public's responsibility to shun journalism that is unethical.

Despite the increasingly poor journalistic integrity from contemporary news-media sources, people from all sides of the political spectrum continue to consume it unquestioningly. Therefore, by consuming unethical erroneously reported that the media, America continues to enable fake news and bad

According to The New York Times, there seems to be a steady decline of art education in public schools across the United States, and it's almost become universally accepted that creativity isn't as important as academic pursuits in public schools anymore. There isn't a school district in the country that hasn't been affected by difficult budget decisions. For years, national media coverage has highlighted teacher layoffs and program cuts in almost every part of the country. While states and districts come to terms with a new financial budget, a new Federal Department of Education reports that arts are suffering the most under today's budgets that are given to public schools, which can really hurt a child in their education and Future creative thinking.

In addition to less money being spent on education because of the very recent recession and various government policies, including the No Child Left behind Act and the Common Core State Standards have placed greater emphasis on core subjects, such as math and reading. In doing so, they have sidelined arts education and made them seem irrelevant in a child's education. In light of these policies, school districts began re-directing funds toward subjects that require standardized testing in order to increase the overall scores of their students. In simpler terms: They cut down on art classes to make room for classes they felt were more important.

A survey carried out by The New York Times found that during the 2009-2010 school year, music education was offered in 94% of elementary schools, and 83% of elementary schools nationwide offered some kind of arts instruction as well. Fewer schools offered any kind of dance or drama classes, with only 4% of elementary schools offering dance and even fewer, 3%, offering drama. The numbers represent a 20% decline since 2000-2010 school year.

For some reason the government thinks every child wants to be a nuclear engineer or a chemist when they graduate and go off to college, which in reality it's far from the truth. First and foremost, art education improves the overall performance of students including in the core academic subjects that are often emphasized by standardized testing requirements. The New York Times said that Students who took four years of art classes scored 91 points higher on their SAT exams than those who took half a year or less. Multiple studies also confirmed that there is a correlation between art engagement and students' other achievements. Students who regularly participated in art classes were four times more likely to be recognized for their achievements.

Art can inspire students to create and express themselves in a variety of forms. It provides the spark that keeps children engaged and allows them to have fun while exploring the world through different art forms. It creates the future dancers, filmmakers, writers, painters, musicians, sculptors, actors, animators, and poets of our world and if that's not a reason to keep art programs in our schools, what is.



Odd comparison, but it reminds me of Forrest Gump telling his story to the people on the bench. Any quote in this book could be a mantra for your life, all inspiring something in the midst. The stylistic choices of the writing made it simple enough to understand what the message is, which allows for deep interpretation into your own life.





between his friends and trying to open doors for himself with opportunities that will get him out of the South Bronx; the show features characters from different backgrounds and


The show sheds light on the many struggles the characters have to deal with. Some of those being racism, homophobia and whitewashing,

Because of the shows abilities to display these topics in an accurate way, the show has become popular with teens, and on Twitter it has grown a large fanbase.





Student of Cheating among students rising Cheating proves easy as going to school

a lot easier to do so nowadays. It may seem surprising to older generations, but today cheating in school is about as common as simply going to school. Cheating in school has become something that administrators are scrambling to find an answer to, and as technology continually becomes smarter than humanity, it's an issue far


Why exactly do students cheat and is it really to their advantage? Some argue that since school has become more challenging through various government mandates (common core, AIR testing, STEM) and a higher level of competition for college acceptance, students feel driven to cheat just to keep up. Others will blame cheating on a declining moral climate in our nation, where students have a dwindling conscience and no recognition for values and ethics happening all the way from middle school to college.

A professor at Hunter College in New York City, Angelo Angelis, was grading students' papers on the story of Paul Revere when he noticed something strange. A certain passage kept appearing in his students' work. He said It went like this: "Paul Revere would never have said, 'The British are coming, the British are coming,' he was in fact himself British, he would have said something like, 'the Redcoats are coming.' "Angelis typed the words into

Google, and found the passage on one Web site by a fifth-grade class. "Half a dozen of his college students had copied their work from a bunch of elementary school kids", he thought. "The Website was very well done", Angelis said. For fifth graders, he would give them an "A." However his college students deserved an "F" he said.

Accurate numbers are hard to come by, but according to a 2002 confidential survey of 12,000 high school students, 74 percent admitted cheating on an examination at least once in the past year since the

survey was released. Numerous projects and research studies have shown that frequently reinforcing standards, to both students and People have been cheating forever; it's just that it's teachers, can lessen cheating. But experts say most schools fail to



Many school staffs say that along with students, schools and technology, parents are also to blame. They say that the parents cite surveys and anecdotal impressions to make the case that since the 1960s, parenting has shifted away from emphasizing obedience, honor and respect; instead many believe it's their job to promote children's happiness while approving their ambitions material success in their futures.

"We have a culture now where we have real

trouble accepting that our kids make mistakes and

fail, and when they do, we tend to blame someone else," said Tricia Bertram Gallant, author of "Creating the Ethical Academy, "Thirty, 40 years ago, the parent would come in and grab the kid by the ear, yell at him and drag him home."

Many people don't get that things aren't the same as they were thirty to forty years ago, It's not that cheating wasn't around then; it's just that cheating today is much easier to accomplish than it was back in the day and many students just don't see that it is wrong, it's so easy that some people might wonder if I wrote a single word on this page.



We told them what happened and asked how Andy was doing; we were soon escorted back to his room to see for ourselves. He ended up being completely fine, leaving the hospital with an arm full of stitches.

Moral of the story: be safe on the river; it can be a lot more dangerous than you think out there.





Two years of class come to an end




