### Protesters being arrested

Starting back in late May, caused by police brutality, and the death of African-American George Floyd, BLM protests began occurring across the United States. Protests have varied across American cities, but some have caused protesters, for one reason or another, to be arrested. The consequences of these arrests have varied from large fines to jail time. While for a good cause, a number of protests have gotten violent, causing protesters to be arrested. "Demonstrations against racism and police violence led to more than 7,600 arrests in the U.S. in May and June," The Time. Something that not many people realize is just how much of an impact getting arrested can have on someone's life.

According to The Time, protesters can sometimes face up to a year in prison, and a fine of up to \$5,000 if convicted of resisting arrest. Even worse, after getting charged with a misdemeanor, the charge will still show up on background checks after they're acquitted or the case is dismissed. Just being charged with breaking curfew can cause problems later on. Despite this, there are still more ways in which protesters have been arrested.

As previously stated, not all arrests are because of violence.

According to Associated Press News, one example of a non-violence arrest took place in early July, when two protesters were charged with unauthorized dissemination of intelligence data (a felony that carries up to five years!). The two individuals were accused of stealing a confidential police document (an intelligence bulletin from an officer's back pocket) and displaying it during a



television news broadcast. Another, more recent example took place on a Friday morning in early September, when a total of nine protesters were arrested in Seattle for disorderly conduct, after using their cars to block the I-5 Ship Canal Bridge during a protest. According to The Stranger, while only nine were arrested, a total of around 40 protesters participated in the demonstration. Not only did this demonstration slow down traffic by a substantial amount, it is even thought to have caused a three car collision that happened on the northbound lane of I-5. When you think about it, this is a very tough time, given the current situation the world is in due to Covid-19. Large gatherings can endanger your life as well as those around you. Despite this, it is somewhat inspiring to know that people will still fight for justice and what's right despite the threat of Covid-19 to worry about. Even if some arrests are unfair, or if they are justified and protesters went too far, it's good to know that people will still join together when injustice occurs. BLM protesters have gotten arrested for reasons ranging from breaking curfew, resisting arrest, blocking a bridge, and even stealing police documents. The smallest misdemeanor can have substantial impacts on their futures as well as those of their communities. Whether protesters are fined or charged with jail time, we should remember that they were fighting for what's right and that they are fighting because of the horrible death of their fellow American.

# Remembering Chadwick Boseman

It has been over six weeks since the world was shocked by the news of the tragic death of actor, Chadwick Boseman. The actor, best known for his recent role as King T'Challa in *Black Panther* for the Marvel franchise passed on the evening of August 28 after losing his battle with colon cancer. He was 43. Boseman's peers and coworkers were saddened at the loss of such "an incredible talent and such a great human being." Many actors expressed their gratitude towards working with him. "From Marshall to Da 5 Bloods, August Wilson's Ma Rianey Black Bottom." All of which were revealed to have been filmed during Boseman's cancer battle. It's clear that Boseman left a profound impact on the world around him, but none so great as the impact that he left with his role as King T'Challa in Marvel's *Black* Panther. The theatrics were stunning, the action kept viewers on the edge of their seats, and the plot drove home values that had never been portrayed in any superhero movie. 

#### Pro-Democracy Protests Challenge the Thai Monarchy

Since 1932, Thailand has existed under a constitutional monarchy. It has gone through almost a century of political turmoil, undergoing seventeen different constitutions, and twelve military coups. But now, the entire governmental order is being challenged, confronted directly and led by the students and young people that will one day inherit the future.

There has been a long history of protesting and political unrest in Thailand, but nothing of this scale, and with this radical of a message. The initial protesting was no doubt sparked by the disillusionment with the system that befell millions of people (particularly the youth) in 2019. It was the first election since the coup in 2014, and people were hopeful; but this hope was quickly dashed, as the same leader of the coup was elected prime minister. Beginning in July, masses of people have taken to the streets, carrying the new, revolutionary message to reform the monarchy.

Thailand operates under lese majeste law, meaning that

no one is permitted to speak out against or criticize the monarchy; doing so could result in a prison sentence of up to fifteen years. From early childhood, the people of Thailand are taught to revere and admire the monarchy. They are taught that it is the cornerstone of the government, and is essential to the running of the country. This belief is deeply ingrained in the older generations, and the younger ones are starting to question the validity of the monarchy, especially as new ideas are circulated through the online world. The main driving force behind the movement is an umbrella organization called the Free Youth; it's leaderless and incorporates many different student led groups. One very prominent activist is Panusaya Sithijirawattanakul.

She has become one of the many student faces of the movement, standing for democracy and reform. At a demonstration in August, Panusaya read out to thousands of people the ten-point manifesto that the movement demands from the government. It includes such reforms as creating the monarchy accountable to the elected institutions, disbanding the royal offices, a new constitution, cutting the budget, and preventing the monarchy from interfering with politics, meaning the House of Representatives and the Senate, and other government branches.

For Thailand, even these seemingly mild demands are entirely new and radical. No pro-democracy movement has gained this much strength and momentum, either; and, due to these circumstances, the movement has received backlash and condemnation not just from the government, but from older, conservative royalists too. This has created a quasi-divide between the older and younger generations. The monarchy still has a tight ideological hold on the more traditional, older folk, but it seems that the passage of time will naturally normalize and spread the new ideas of the youth.

On September 20, the protesters celebrated with rallies after succeeding in handing the manifesto to the authorities. The whole country waits in anticipation to hear the response from Maha Vajiralongkorn, the king, and the rest of the government. Whatever the result may be, this is, without a doubt, a historic moment for Thailand,

# Justice For Breonna Taylor

On May 25th, 2020, Derek Chauvin killed George Floyd as he knelt on Mr. Floyd's neck for 8 minutes and 46 seconds (nytimes.com). His death, alongside many other Americans who have been killed due to police brutality, have sparked protests under the "Black Lives Matter" campaign.

After Derek Chauvin killed George Floyd, many protests arose for his arrest. Eventually, he was charged with 3rd-degree murder and 2nd-degree manslaughter, but it has since then been raised to 2nd-degree murder (nytimes.com). It took multiple days to arrest Chauvin and get George Floyd the justice protestors were calling for.

Mr. Floyd was not the only one devoid of justice. March 13th, 2020, Breonna Taylor was killed in Louisville, Kentucky by police officers who raided her home in the middle of the night. According to BBC, The police acted on a "no-knock warrant," which meant that they could enter Ms. Taylor's apartment without warning. They entered Ms. Taylor's home with a battering ram

looking for drugs. There were no drugs found in her home. Breonna Taylor was asleep with her boyfriend, Kenneth Walker when they were woken up by noises. Mr. Walker (a licensed gun-owner) opened fire with his gun for self-defense believing Breonna's apartment was being invaded. The police then shot and killed Ms. Taylor.

Protestors are still demanding justice for Breonna Taylor. Out of the 3 officers who were involved, only Brett Hankison was fired in June prompting days of protests in the streets of Louisville (washingtonpost. com). According to USA Today, "Protests in Louisville have continued for 89 days as local marchers demand systemic change and the prosecution of the three police officers involved in the death of Taylor, a Black woman who was unarmed when she was fatally shot in her apartment during a narcotics raid that turned up no drugs." This was written on August 25th. It is almost October and the protests are still happening because nothing has been done.

There is some good news, however, "the Kentucky Attorney General is expected to announce whether or not to charge the officers involved in her death," says Darryl Forges, a CNN National Correspondent. All protestors can do now is continue to demand justice. Breonna Taylor was killed on March 13th, 2020. That is about 191 days with no response to the incident and no justice for Breonna Taylor.

September 21st, 2020, the LMPD (Louisville Metro Police Department) declared a "state of emergency" ahead of the Breonna Taylor decision in court. Thus prompting people to believe bad news is coming.

September 23rd, 2020, the grand jury in Kentucky indicted Brett Hankinson on three counts of "wanton endangerment." This charge has nothing to do with Breonna Taylor's death but rather the individuals who could've been hurt by the gunfire. According to Daniel Cameron (Kentucky attorney general), "The shots he fired had passed through Ms. Taylor's apartment walls into a neighboring apartment, endangering three people there," (nytimes.com).

If you would like to help those affected by police brutality you can sign petitions on change.org, donate, spread awareness, and go out to protest. However, if you protest, be mindful of your surroundings and stay safe.

### NBA Moves Toward Justice

The NBA, since returning on July 30th, has not only been in headlines in the sports world, but also those of social justice. Although many changes were made to the game, including the virtual fan screen, piped in crowd noise, and other audio cues to simulate a regular game, other changes included new stances against racial inequality. Players were allowed to put certain phrases on the back of their jerseys to support racial equality, including, "How Many

More" and "Justice Now." Additionally, the phrase "Black Lives Matter" was printed across the top of the floor, visible to all spectators during the game.

Things were seemingly starting to settle in, until footage of Jacob Blake being shot by the police seven times was released on August 23.. This sparked yet another uprising in the NBA, leaving many players wondering what they

could do better than the actions they were taking the first time an incident like this happened. The solution that they came up with was to boycott the upcoming games. Led mainly by the Milwaukee Bucks franchise, players refused to take the court for warmups for Game 5 of the first round playoffs. Other teams followed shortly thereafter, resulting in a postponement of the NBA altogether. Those within the bubble decided to call a meeting, inviting everyone to share their ideas of what the next steps should be for balancing the resumption of the NBA and calling attention to social justice.

Through multiple sources, NBA insiders confirmed that almost all teams wanted to continue playing basketball. The only teams to vote no were the Los Angeles Lakers and the Los Angeles Clippers. Ironically, at the time, these were the two teams that had the highest odds to win The Finals. After the NBA boycotted their games, a number of other professional sports organizations and players followed suit. This included the Milwaukee Brewers, the WNBA, and Naomi Osaka, a well-known tennis player.

In the aftermath of the boycotts, Adam Silver, the commissioner of the NBA, issued a statement describing the actions that will occur to address racial inequality. Both the NBA and its player's association decided that they wanted to place an emphasis on civic participation and voicing their opinions. In order to solve this problem, in every city that has an NBA franchise, the arena will be converted into an in-person voting venue for the 2020 general election. Next, the NBA pledged to include

advertising in the remaining NBA games encouraging voting and the facilitation of voter access.

In an NBC News interview with head coach Doc Rivers, he says, "At the end of the day, it's not the NBA's job to solve the world...It's the NBA's job to be part of the world," While the NBA might not have all of the solutions to the issues of racial injustice in the United States today, Rivers does believe they can do their part with the platform that they have to raise awareness for the issue at hand. All in all, the NBA has made a positive impact on not only their players and staff, but on the people of the United States.

For the first time since 2003, the Cincinnati Bengals had the first overall pick of the NFL draft. Our home team decided to take their chances on senior quarter-back from LSU, Joe Burrow. This MLB season has been one like no other. The threat of the Coronavirus and the subsequent standoff between owners and players on salaries and number of games made it seem as if the teams would never take the field. But after much deliberation, the league settled on a 60 game season.

This was great news for Cincinnati Reds fans back in July. The Redlegs had an offseason of incredible talent acquisition. Nicholas Castellanos, Mike Moustakas, and Shogo Akiyama were the big names the Reds acquired. Moustakas, and Castellanos were secured on 4 year, \$64 million dollar contracts while Akiyama signed a three year \$21 million deal. These power hitters and excellent fielders, coupled with the best starting rotation the Reds have had in years gave fans cause for excitement.

However, Reds fans realized quickly that this crazy season would not be a walk in the park. The Reds split

### Protests erupt across Belarus following election

A glance at contemporary Europe may seem to find a continent liberated from the grip of facism and dictatorship that left its permanent mark upon the 20th century, changing the entire world in the process; but a closer examination reveals a lingering afterthought in the form of the authoritarian president of Belarus, now serving his sixth consecutive term: Alexander Lukashenko. The elections of 1994, the first year of his reign, have been deemed to be the only credible election of the total six, the rest being rigged and manipulated in favor of Lukashenko, with the most recent election bringing him a share of 80% of the votes. Even with a dismissal of the criticism from a number of officials and activists alike deeming the election unfair, a cursory analysis of the current state of public opinion in Belarus would lead one to question the authenticity of the election. Even the U.S. Secretary of State, Mike Pompeo has stated that the election "was not free and fair."

Amidst protests and demonstrations across the country, Lukashenko became the president of Belarus on August 9, 2020, embarking upon his twenty-sixth year in office. The political unrest has since swept the country, the nucleus being in the country's capital, Minsk. It's brought hundreds of thousands of people out into the streets, demanding the resignation of Lukashenko, and the implementation of free and fair elections. Although this year the protests have been particularly widespread and explosive, it's certainly not the first time that Lukashenko's regime has been challenged by the people; in 2011, thousands of people participated in peaceful protests, learning very quickly that any verbal opposition would result in imprisonment. This year, though, the people of Belarus have decided that they will not tolerate the regime, and are fighting back with an unbreakable spirit; but the government crackdown has been just as ruthless.

Even since before the election results, a heavy police presence has been deployed in Minsk in anticipation of protests and demonstrations by the public. Since then, the confrontations have become increasingly violent as the regime mercilessly snuffs out dissent. Skirmishes have been raging in the streets; stun grenades, tear gas, and rubber bullets have all been utilized by the police, even against peaceful demonstrators, and one video even shows a police van being driven into a crowd. In addition to all this, the police have performed arrests on thousands of people. These arrests usually involve protesters being thrown into police vans, where there have been many accounts of torture, humiliation, and beatings.

One victim, Marylya, told the BBC that, "We heard them bring a guy in and heard the rhythmical thumping of their batons on him. Several people were beating him up cruelly. He begged them to stop, but they swore and carried on. It was terrifying."

The regime is showing no signs of ceasing its hold over the people of Belarus, and is using all the means available to control the opposition. Only the months ahead will shed light on the future of Belarus, as the

#### SpaceX's Steps Toward Commercial Space

On May 30, 2020, SpaceX launched its Crew Dragon, carrying two astronauts to the International Space Station. Ahead of the launch, SpaceX had completed 62 successful test launches in a row. This was the first time since 2011 that the United States sent a person into outer space. Seemingly appearing out of nowhere, two questions that many people asked after this launch were, "What is SpaceX and where did the company come from?" SpaceX started as an idea that Elon Musk had in 2001, in which he wanted to grow plants on Mars. Essentially, Musk wanted to start a space exploration business by himself, that could regain public interest in space exploration and ultimately occupy Mars. At the time, this idea sounded completely unachievable. However, Musk took many steps through the next few years that would make his dream of colonizing Mars somewhat comprehendible. A year later, Musk began to staff his business idea.

Musk partnered with rocket engineer, Tom Mueller, which gave birth to SpaceX. Musk's first attempt at building a rocket came when he traveled to Russia. In Russia, Musk's goal was to buy renovated Intercontinental Ballistic Missiles, or ICBMs. Musk learned that the Russians wanted \$8 million for the ICBM. To that, Elon Musk replied with, in an interview with the New York Times, "I think we can build these rockets ourselves." After a bit of research, Musk calculated that only 3 percent of the total cost of building a rocket was allocated toward raw materials. With this research under his feet, Musk and his partner, Tom Mueller, built SpaceX's first rocket, which failed just 33 seconds after lift-off. The second and third rockets launched in 2007 and 2008 were both as unsuccessful as the first. Musk only had the funds for four rocket launches, so the final launch had to be successful.

On September 26, 2008, SpaceX launched the Falcon 1 successfully into orbit. Following this success, Musk's private company received a grant from NASA of \$1.6

billion and the company would be responsible for cargo transport to the International Space Station. In 2011, SpaceX announced its Reusable Launch System Development Program. This program was designed to make launching rockets much more cost effective. Within this plan, Musk designed a way to catch the part of the rocket that was not sent into orbit in order to reuse them. Before this idea, the first stage of the rocket simply burned up as it reentered the Earth's atmosphere.

After four years of developing this technology, SpaceX found success when they landed the first stage of their rocket: a part that can be reused. Two years later, SpaceX completed a launch with this same reused rocket. Musk claims that this reusable rocket is the key to commercial cost effective space travel, which had been a goal for SpaceX since the beginning. Today, SpaceX has completed 40 missions with reused first stages of rockets and has proved to be the only successful and cost-effective space travel company that the United States has ever seen.


The virus heard round the world... literally. COVID-19 has affected nearly every aspect of the daily life of billions of people. But adaptability through this tumultuous time has not been exclusive solely to individuals. Many businesses are using this time to reflect on and adjust their work schedule policies. Facebook is among many businesses that have stated that they are considering the possibility of allowing their employees to permanently work from home. CEO of Facebook, Mark Zuckerberg had this to say about his company's response to the COVID crisis: "I'm very proud about how our teams around the world have pulled together to support people – getting accurate information, fighting misinformation, supporting small business and their recovery – making sure that important social and communication services that people rely on to keep in touch with the people they love, stay stable and running." In addition, many

companies will begin today by making most of its US job openings eligible for remote hires and begin taking applications for permanent remote work among its workforce as soon as later this year.

Although most Fortune 500 companies are using this time to reevaluate and adjust their employee policies, the case has not been the same for small businesses in America. The virus's impact on small businesses in America began back in March when numerous state governors issued stay-at-home orders for their citizens. In a survey conducted by Proceedings of the National Academy of Science through Alignable, of more than 5,800 small businesses between March 28 and April 4, 2020, several themes emerged. The results of the survey showed a multitude of different facts related to the impact of COVID-19. First, mass layoffs and closures had already occurred just weeks into the pandemic. Second, the risk of closure was negatively correlated with the predicted length of the crisis. Many businesses had varying expectations concerning the likely duration of the COVID-19 disruptions. Third, many small businesses' financial states are very fragile. On average, businesses with more than \$10,000 monthly in expenses only had about 2 weeks worth of cash on hand, leaving them susceptible to heavy financial loss in the event of a halt in business. Fourth, a large majority of businesses planned to attain funding through the Coronavirus Aid, Relief, and Economic Security (CARES) Act. However, various anticipated issues with accessing the problems arose, such as establishing eligibility for aid through the program. Through these uncertain times, communities have begun to rally around the small businesses in their areas. Many people have money to spend due to a lack of opportunities to socialize and in turn, disburse money into their communities. As regulations are beginning to be lifted, many people have flooded their local businesses with support, which could be the saving grace of small businesses in America. So, if you're thinking about going out, whether that's shopping for a friend or going to get dinner at a restaurant, now more than ever, consider the local businesses in your community.

### Remembering Ruth Bader Ginsburg

On September 18, 2020, Supreme Court Justice Ruth Bader Ginsburg died after a long battle with pancreatic cancer. The Notorious RBG, as she was affectionately called, was appointed to the Supreme Court in 1993 by President Bill Clinton. According to NPR, Ginsburg moved to the Supreme Court after serving as a judge on the US Court of Appeals (the second-highest court in the US) for the Washington D.C. Circuit for thirteen years. Ginsburg was the second woman to serve on the Supreme Court, the first one being Sandra Day O'Connor. O'Connor was appointed in 1981 by President Ronald Regan and served until 2006 when she retired.

Ginsburg was a champion of women's rights throughout her whole career and did not stop fighting for them until her death, even when faced with many adversaries. She still worked while getting cancer treatment after being diagnosed with pancreatic cancer in 2009. Although she had been urged to retire for the last few years, she didn't because she knew her job was far too important. As the subject of two movies and numerous books, Ginsburg has become a pop culture icon over the last few years because of her strength, resilience, courage, and character. She was arguably one of the most influential Supreme Court Justices in modern times.

Supreme Court justices are nominated by the president, then are voted on in the Senate. If the Senate votes to confirm a nominee (which requires a simple majority vote)

they are appointed to the Supreme Court by the president. With Ginsburg's death coming just forty-six days before election day, people have started to debate if President Donald Trump should be able to appoint a new justice before then, as he may be voted out of office. Ginsburg herself thinks he should not be allowed to. According to NPR (National Public Radio), a few days before her death, she said, "My most fervent wish is that I will not be replaced until a new president is installed." However, According to The New York Times, President Trump has said he wants to replace Ginsburg, "without delay." If President Trump appoints a new justice, the Supreme Court will have three liberal justices and six conservative justices. This means that the conservatives are the majority and even if one conservative justice votes with the liberal justices on a decision, the conservative justices will still be the majority. This could put Supreme Court decisions such as Roe v Wade and Obergefell v Hodge among others, in danger because generally speaking, they follow the liberal set of beliefs. Some people are concerned that there is a possibility that a Supreme Court that has a conservative majority might try to overturn those decisions.

Ruth Bader Ginsburg was, and continues to be, a role model and inspiration for many people. Her strength, resilience, courage, and character truly made her special. She lived an amazing life and should be fondly remembered for everything she accomplished throughout her career. It is undeniable that her loss is a great one and that she will be greatly missed.



### TikTok

There has been much speculation recently regarding the popular video sharing app, TikTok and whether it will be banned by the US government. President Donald Trump wants to shut down the social networking app because it is owned and operated by China's ByteDance. Trump is worried that with over 100 million users in America, the company could leak our personal information to China. Without TikTok, many influencers such as Bryce Hall, Charli D'Amelio, and Addison Rae, who get their income through the app, would be without jobs. The app was created in September 2016 as a replacement for the popular video-sharing app at the time, Vine, which was shut down December of 2016 by its owner, Twitter. Vine failed however, not because of security concerns, but because of loss of revenue, something TikTok does not need to worry about at this time. Currently, the US Department of Commerce is trying to work out a deal in which an American based company could buy out TikTok to avoid the ban completely. Though nothing has been finalized, the software company, Oracle, has interest in the deal, which would give 25,000 jobs to Americans. If TikTok were to change ownership to an American company, some students believe that there may be some changes, "I think the app would be altered because the algorithm that is used to present videos on the "For You Page" would be different," said Ryan Sewell (12). After coming close to finalizing the trade deal, China said that they would not approve it because they would lose a great amount of money, as the app has a project revenue of over \$1 billion by the end of 2020. China referred to

the potential agreement as "dirty" and "unfair" because the reasoning given by the US Department of Commerce was over "bullying and extortion" of American users. Many LHS students use TikTok to express their creativity, frequently making videos and scrolling through the "For You Page" such as Cindy Sanders (11). When





asked how much time she spent on the app, Sanders said, "I spend about 6 hours a day on Tiktok, I don't know what I would do without it." While some students love TikTok, others see where President Trump is coming from. Brock Perkins (12) had this to say, "I'm not sure if I believe it (the TikTok ban rumor) because they have said it before, but it could be a smart move because China would be getting all of our personal information." If the United States goes through with the ban, they would not be the first country to enact censorship. In July, India banned TikTok (along with 60 other Chinese mobile apps), citing national security concerns because of ongoing conflict with China. Indonesia enacted a temporary ban on the platform in 2018 and Japan is also coming close to banning the app for the same reasoning of security concerns. As this presidential term comes to an end, we hope that the government will be able to figure out how to solve this security problem, so we can enjoy the sharing and watching of videos on TikTok for good.
